ACGS MEETING OF BOARD OF DIRECTORS 19 SEPTEMBER 1995

CALL TO ORDER A regular meeting of the Board of Directors was held on Thursday 19 September 1995 at the ACGS library. President Roger Lawrence called the meeting to order at 18:41.

ROLL CALL

Lucille Lagassé was excused. Also in attendance were Mary Jean Colburn and Pauly Labbé.

RECORDING

SECRETARY The minutes of the 10 August 1995 meeting were reviewed. Several corrections

were offered. The notes will be filed as corrected.

TREASURER'S REPORT

Pauline Cusson:. There being no way to really reconcile the June report, it was decided to accept it and file it for audit. The August report -- last item before total expenses on page 2 --- represents the \$227 adjustment from reconciliation. Pauline needs to analyze the figures for the building fund. Some discussion as to the status of unreceived pledges. Pauline also included some pie charts and bar graphs to help explain income and expenses, both projected and actual. Roland questioned the 3rd graph which shows that the expenses for membership exceeds the income from membership. This is explained by including the cost of the Genealogist in the membership expenses. It was felt that this will balance by the end of the year. Roland suggested that these graphs have explanatory notes attached. Don questioned why the actual income for several categories differs from the "income vs expense" graph to the "actual vs projected" graph. No good explanation for this --- will work on it. Don pointed out a few possible reasons. Report to be filed for audit.

SOCIETY **BUSINESS**

Fall conference plans. Registration site will be downstairs. Roger said that he, Pauline Cusson, and Anne-Marie met to discuss. Our Lady of Cedars church has offered to loan us chairs. Question as to availability of hot water for tea. Talbot's will arrive by 07:30 with coffee ready to serve. Some cleanup work needs to be done. Could we get some non-board members to help? Computer, Roland Marchand. PC's are set up for Judy, Anne-Marie, and Pauline with DOS 6.2 — one with Windows. He is working on an inventory of PC's. Membership, Judy Arseneault. Michael sent out 194 postcard reminders this month. 77 new members in August. Brought in \$520 in donations. Out of 120 up for renewal in July, 96 renewed. She noted that after 3 months, they send out a reminder to those who have not renewed. Judy says the net increase in membership each month is about 25.

Building, Ray Desfosses. Dave's Landscaping Care says they have not yet been paid for the May mowing. (They have been paid for July.) The check was made out (for \$155). Pauline will issue another if it appears to be lost. (It probably didn't get mailed.) He needs a master key for the fire box. Anne-Marie has one for him. PSNH came down to read the meter on a Monday. Ray told them our hours and said he would not accommodate them on off hours again. Two urinals have been fixed. He intends to start the boilers in time for the fall conference. Roger said he's been thinking of removing the fence gates as we never use them. There was an alternate suggestion that we swing them back against the fence and secure them.

Editorial board, Anne-Marie Perrault. Still having trouble getting out the summer issue of the Genealogist. Should have it by next week.

Library. Roger introduced our new library director, Mary Jean Colburn. She received her master in library science from URI. She has been a member of ACGS for quite a while and speaks and writes French fluently. Pauly will stay on as assistant library director. She reported on the day to day activities of the library. She said she has had problems with prices of some of our publications—not adequately marked. Don asked if there were a complete list of what we have to sell available. He would like to post the list on CompuServe's Genealogy Forum.

Acquisitions, Bob Maurier. Books are back from bookbinders. The order sent out in March has come in and was sent to the binders this week.

Research, Pauline Côté. All is going well with research. Some of the requests are for items that we have no data on. If they include an SAE, she will try to steer them in the right direction. Regarding publications, St Joseph's of Laconia should be soon ready to go to the printer's. St Basil's will also be ready soon. Proofs went to St Francis of Winooski this past weekend.

UNFINISHED BUSINESS

Roger reported on State Library occupancy. They have been moving things in. They seem satisfied with the cleanliness of the facilities.

He then turned to mortgage plan revisions and said these were to be discussed by a small group later.

<u>NEW</u> <u>BUSINESS</u>

Roger thinks that we could (at some time) get a crew together to clean the upper floor. Pauline Côté said she would prefer cleaning up the outside of the building first.

Roger reported on PC for sale --- 161 MB HD, 4 MB RAM, 33 MHz, \$600 --- anyone interested?

Pauline Côté said she has enjoyed her 4 years on the board and wishes us well. Don noted that last month's minutes said we would discuss the Maine chapter's continued affiliation with us. Roger pointed out that most of what they have for holdings belongs to us. Our by-laws would have to be changed to allow a divorce. As it is now, any income they generate gets reported to us at the end of the year. Is there really an issue here? Do we (or they) really want a separation? Should a dissolution come, the board should discuss and decide the division of assets.

Anne-Marie asked about our next board meeting. It's scheduled for 12 October when many of us may be at the Burlington conference. The 19th was suggested, but neither Anne-Marie nor Jack would be available then. It was then scheduled for 05 Oct.

Pauly reported on several books which appear to be missing from the library.
