# **ACGS** MEETING OF BOARD OF DIRECTORS **11 DECEMBER 1997**

CALL TO ORDER A regular meeting of the Board of Directors was held on Thursday 11 December 1997 in the library. The meeting was called to order by president Albert Hamel at 18:35.

**ROLL CALL** 

A quorum was present. Roland Marchand and Bob Maurier were excused.

**RECORDING SECRETARY** 

Gerry Nash moved acceptance of the November minutes; Anne-Marie Perrault

seconded: motion carried.

TREASURER'S **REPORT** 

Gerry Lalonde distributed a revised copy of the October report. Deficit mainly due to purchase of Jettés. Gerry Nash pointed out that this was more of a cash flow statement than a profit and loss one. This will change in Jan when Gerry Lalonde changes to QuickBooks. File for audit. [See attachment 1.]

VICE-PRESIDENT Bob Paquette gave an update on spring conference. Larry Autotte is very busy (and cannot handle the conference). Bob Paquette asked if we should have a full blown conference or a workshop like this past spring. Consensus seems to be going with the workshop format. Anne-Marie Perrault said that she had the structure of the previous one. Mary Anna Paquette voiced approval for the workshop format. Gerry Nash suggested that we could have a meal catered here.

**PRESIDENT** 

All Hamel reported that renovations are coming along well. In some places 4 coats of paint were needed. Plumbers will be in to cover elbow. Ceiling grid work is coming along. Floor tiles and ceiling tiles are here.: There was a problem regarding the NH Library. Last time we got money from the state was in July. Al Hamel has a letter from the state saying they would not be seeking a renewal of their lease. They haven't been paying because we haven't been invoicing them. A copy of the lease agreement cannot be found at the Library. Letter from the state showed that ACGS (Don Chaput ) had signed on 05 Sep 97. It appears that the lease was to have gone from 01 Jul 1997 through 30 Jun 2000. The state had wanted to have a constant rate for the life of the contract; ACGS had wished to have the option to increase from year to year if needed. Gerry Nash reviewed the letter and determined that they would sign the contract provided we made the 4 changes they desired. Exhibit B of the contract specifies that ACGS must invoice on a monthly basis. Gerry Nash suggested that we (Al Hamel) initial on behalf of the ACGS where the state has initialed. Help: Al Hamel is working on the letter to Manchester area members. Fund drive: Gerry Nash suggested that a notice be put out explaining the needed for additional funds and asking for pledges. Gerry Lalonde reiterated that, during the last drive, the telephone calls really helped. Gerry Nash and Roger Lawrence volunteered for the phone bank. Lucille Lagassé will be asked for her help in getting the phone bank. Meetings w/chairs & departments: Al Hamel is and will be continuing to do that. Lenses for Dukanes: Al Hamel is not sure what lenses would be best for these readers. Mary Jean Colburn said that they use 32x lenses; she will talk to Bob. Web page: Al Hamel will be meeting with Ron Niquette at 1830 on 18 December to discuss this .... content and price. Sam Harris suggested that advertising could defray costs. Al Hamel does not wish to do it at this time.

# COMMITTEE REPORTS

**Acquisitions**: Al Hamel reported that Bob Maurier had written to Québec bishops re getting permission to purchase certain records from the Mormons. They will discuss at their Feb meeting.

Buildings and Grounds: Bob Paquette reported that we need a paid handyman (we have a paid janitor). He did find someone (an Manchester Fire Department retiree) who would be willing to do this for a few hours a week @ \$15. Mary Anna Paquette said she was speaking with Andy (the janitor) who said that we need a commercial vacuum cleaner. A backpack vacuum cleaner was suggested. Gerry Nash moved that we appoint someone (Gerry Lalonde offered to be that someone) to look into purchasing one; Gerry Lalonde seconded; motion carried. Consensus was that we pursue hiring the retiree (Maurice Duval from Hooksett). Gerry Lalonde so moved; Gerry Nash seconded; motion carried. Bob Paquette will get together with Ray Desfosses and get Maurice Duval primed on the heating system.

**Computers**: [Al Hamel reported in Roland Marchand's absence.] New computer has arrived. QuickBooks has been loaded by Bob Neveux. We have received a software gift from Br¢derbund .... Family Tree Maker v4.0. [See attachment 3.]

**Conferences**: Roger Lawrence said that Pauline Cusson and Richard Fortin seem to want to plan it (the 25th) alone. Roger Lawrence thinks it needs more people. Anne-Marie Perrault suggested that there be an odd number of people in the group. Al Hamel will be #3.

**Editorial**: [See attachment 4.] Anne-Marie Perrault showed a draft of the American Canadian Genealogist cover for the 25th. She and Roger Lawrence are still working on the guidelines and will have them finalized by the end of the winter. Gerry Lalonde asked if he could see them for possible comment. Anne-Marie Perrault said they are looking for consistent terminology.

**Library**: [See attachment 5.] Al Hamel asked about the "missing books". Mary Jean Colburn said that they "come and go" ..... many are simply misfiled. She does think, however, that some books are actually walking out of here .... and not returning. Al Hamel asked if we should consider a security system. Mary Jean Colburn said it would be expensive but would be a good idea. We really should protect the repertoires. The detectors she uses in her library have to be placed in the spine of the book. **Membership**: Our numbers are well over 6000. We have about 3000 active.

Publicity: No person assigned.

**Research**: [See attachment 7.] There is a list of research efforts by date ..... also one by dollars.

Internet: [See attachment 8.] (The questionnaire stops in February 1998.) Also refer to note above on upcoming Web meeting. Gerry Lalonde asked if it would be a good idea to have a "personnel manager" ..... precipitated by the questionnaire item on willingness to volunteer. Anne-Marie Perrault said maybe in the spring.

Inventory: We have 30 new Jettés.

Obituary: Anne-Marie Perrault reported that we are still plodding along.

#### **OLD BUSINESS**

We had talked last month about getting microfilms on Franco newspapers. ACA has been approached, but they would not lend them to us. Al Hamel has talked to a company in Marlboro MA (that does reproductions for Boston City Library) .... New England Micrographics. They charge \$30/roll. We could use the newspaper reproductions for obituaries. Don Chaput said that the obits in L'Avenir National were all copied from the Union-Leader ..... complete with errors. Anne-Marie Perrault is in favor of pursuing this acquisition. A Roger Senecal at the University of Vermont could help us to determine which newspapers would benefit us most. There seemed to be some reluctance to acquiring resources which are otherwise available locally. Anne-Marie Perrault said that last year the Board voted to accept Visa/MC. We've done nothing about it yet. Gerry Lalonde will pursue.

#### **NEW BUSINESS**

Parchemin is a system in Canada where a group of people has gone through the notarial acts and has extracted pertinent info. The fee to lease the service for 2,500\$ CAN per year. There is a small research fee to get into the system plus a price per page. Al Hamel asks if we though that by supplying the service we could recoup the 2,500\$. We have a member who guarantees that we will not lose money the first year. Roger Lawrence said that they had a representative of Parchemin in Québec last year. Anne-Marie Perrault has used it. She asked what we get .... an entry to the Internet or a CD. Al Hamel said a CD. Gerry Lalonde said that we could offer an additional service of translating notarial data from Parchemin. Mary Jean Colburn asked if we could table this until Al Hamel gets additional information. Al Hamel asked what we thought of putting the Jettés on CD. Seemed to be a lot of interest. Anne-Marie Perrault reported on an organization called the Federation of Genealogical Societies. We could join for a relatively small fee and reap considerable benefit. Mary Jean Colburn moved we so do; Roger Lawrence seconded; motion carried.

Roger Lawrence moved adjournment at 20:18; Mary Jean Colburn seconded. Next meeting at the library on Thursday, 08 January 1998 at 18:30.
