## **Meeting of the Board of Directors**

**September 12, 2002**

Meeting was called to order at 6:30 PM.

In attendance were Craig Donais, Marcel Jussaume, Paul Lambert, Muriel Normand, Gerry Lalonde, Julie Smith, Don Chaput and Norma Boyce.

- A. Corrections to the minutes of the August 8, 2002 meeting were noted and then accepted. (The original minutes have been amended to reflect the changes as noted.)
- B. The Corresponding Secretary's Report was accepted as submitted.
- C. Treasurer's Report - Paul Lambert
  - 1. The financial report was not ready, but Paul said he hoped to have it in the Board Member's mailboxes by the following Saturday. He stated he was having trouble with the updated Quickbooks program.






