REPORTS of OFFICERS

Recording Secretary:

• Julie moved to accept minutes of the January meeting as corrected. Anne, second, passed.

Treasurer's Report:

- 1100 assets do not need to be changed since the process of debit and credit is still followed accurately, no invoices will be changed.
- Several revenue accounts up from January 06 however membership is down. Some expenses, particularly heat and plowing, are also down.

COMMITTEE REPORTS:

- Board anticipating need for extensive electrical work and the addition of a dropped ceiling to reduce HVAC costs. Gerry will ask Herb to identify 3 potential vendors so that we may obtain competitive bids.

NEW BUSINESS

- Mary Anna presented several alternative binderies since Atlantic will no longer pick up and deliver. After discussion, she will submit requirements to Acme bookbinding and Higginson, the latter located in Salem (MA or NH?)
- Mary Anna has accepted the position of Library Director to resounding cheers from the board!
- Drouin is coming to Ancestry.ca, we will make no changes on our policies except to highlight our translation services on the Research page. Apparently, they are planning to index it over time with the help of PRDH but will initially simply offer images in the current format.
- We have received permission to publish the records of Phaneuf Funeral Home in Nashua (1906-1930). These records contain addresses as well as items that do not directly with the deaths of individuals. Julie moved to publish the records with addresses as written, second by Anne. Motion carried unaminously. Constance moved to not publish items not directly referencing death of individuals, second Muriel. Motion carried, Julie opposed.





It was with a sense of disappointment that we read your letter addressed to Mr. Bonitatibus, dated 12/29/06. In no way has this society or its representatives ever been less than forthright in its mission to copy, preserve and make available to those seeking to connect to their ancestors the transcriptions of baptisms, marriages and burials that occurred in the church.

Attached please find a rather complete timeline as to how our society, through David's efforts, arranged to copy the various records. We feel that it clearly shows that the copying of records proceeded only after consultation with the diocesan office and with the consent and at times at the request of the pastor of the parish. David's letter has been reviewed by Pauline Cusson and Pauline Cote, members of long standing in our society, who have been instrumental in the indexing of church records in various Northeast parishes. To the best of their recollections, David's letter correctly documents the events that occurred with regards to the Albany Diocese.

After reading Mr. Bonitatibus' letter, it is our sincerest desire that you will reconsider letting us continue what we feel is a service to the diocese in helping preserve information that is so precious to someone wanting to learn more about their ancestors and in providing an index to the parish records that reduces the amount of handling that a fragile parish register is exposed to.

Dear Ms. A. Simcoe:

Thank you for your patience with my tardiness in responding to your Nov 2006 letter. Due to an unfortunate accident I had around Labor Day, I was disabled for almost four months. I was not able to find the information you requested as it was in my attic among some 100 boxes or so. I've moved 3 times since 1995 when my 1st request to the Diocese was initiated. My information is based on notes that I kept and in all cases I don't have an exact date or time, so I will go with the best of my knowledge.

What I'm writing below is lengthy but it is a step-by-step process of what happened from the first contact on this project.

In October 1995 while attending my aunt's funeral, I ran into an old family friend, Father George Gagnon, who was at my family parish from the 1960s to about the 1990s. Father Gagnon had dinner with my brother and his wife and asked me what I was up to. I told him I was a member of a Franco-American group that did good work preserving old church books. Fr. George had heard about the work through his friend (I believe a classmate) from a French church in Worcester, MA, we had copied a few years before.

He asked if we had ever completed any parishes in the Albany area. Being a member of the group for only a few years, I told him I didn't think so but that I would ask on my next visit. After talking with the then President, Pauline Cusson, and the Publication Director, Pauline Cote, they informed me that no work had been done in the Albany area to date. I was advised that they generally received permission in writing to do any work in any Diocese before commencing. In their experience, some Bishops felt it was up to the individual pastors whether or not to have their records copied and alphabetized.

Upon my return to Schenectady, I called Father George at ND Des Victoires in Whitehall and told him what I found out. Father George referred me to Chancellor, Father Paterson. He said I needed to speak with Fr. Paterson about getting a meeting with the Bishop. On that same day, I called the Chancery and spoke to the secretary who in tern transferred me to a nun, Sister Mary Berchmans. She was confused as to why I would be calling her as she was an Archivist and could not give me permission to do any work, though she thought it was a wonderful idea. I was transferred back to Father Paterson's office and was told I would get a phone call sometime soon.

A few weeks later, I received a call from Sister Mary Berchmens. She was told to call me to ask about the work we did. I explained the process to her again. She

said she would tell the Chancellor's office that she thought the project was worth looking into and would have the Chancellor call me soon.

It wasn't until I saw George at my brother's house a few months later that he asked how I made out with the project. I explained my frustration at being transferred so many times and not receiving any calls to date. Fr. George said he would make some calls for me as he really wanted his parish to be completed. His books were going to cost over \$8,000 to have repaired and rewritten in some cases.

In the beginning of January 1996, Father George had me talk to Sister Kathleen (my notes say she was in the pastoral planning office). After explaining the project to her and stating that I needed to meet with Bishop Hubbard to obtain permission for this project, she said she would talk to him and get back to me soon. At the end of the month, I called back and spoke with Sister Kathleen. She referred me to Father Diacetis. She explained to me that he was part of the Vicar board (I'm not sure what this board does) and he would meet with me so I could explain our work and he would review what I had. (My notes say he is a canon lawyer of some type but it has been 12 years and think he told me this but I'm not sure as I was confused as to why I was being sent to Our Lady of Grace in Ballston Lake.)

Father was very kind and was eager to meet with me. The first meeting was scheduled for February 11, 1996 but was canceled as he had a funeral to do. The 2nd date March 5th was canceled as Father had something come up that he needed to attend to. Finally, on March 25th I was able to meet with Father and give him copies of a few of our books. He said he was going to make sure that under Canon law, we were able to copy the records. I had informed him it was our strict policy that we do not put in the illegitimates, adoptions, or annulments. He said he would soon get back to me and took the books to go over them.

In May of 1996 I hadn't heard from Father Tony so I called him so see if we had an OK to go ahead with the project. He said that the information was not civil records and as long has we proceeded under the strict rule of not including illegitimates, annulments, and adoptions we could go on with the project at ND des Victoires. Father thought it was a great idea and was not only going to recommend it to his fellow priests, but asked me if I would copy his parish as well. (Our Lady of Grace was one of our 1st parishes to be copied and the second one we published.) Father advised me that he would talk to Sister Kathleen and give his recommendation to her as well as to the Bishop.

I called the Chancery and left a message for Sister Kathleen (my notes state this date was Friday, May 3rd). Not hearing back from Sister, I called Fr. George in Whitehall and repeated to him what Father Tony had said to me a few day's before. Father George called Fr. Tony who explained to him what he had told me. Father George gave me the go ahead to do the project and wanted me to

start ASAP! I called Pauline Cusson in NH and she said they were uncomfortable not having permission from the Diocese but that if it was left up to the individual priests to decide, they would need at least that much in writing. I explained to Father George why they were hesitating to start the project. After all this time, I realized I was never going to meet with the Bishop but at least I should get a letter from the office.

It was almost four months later in September of 1996 that I was able to get some type of committed permission to go ahead with the project. (My notes say that Sister was now the Co-Chancellor and there was a Father Burke working as Chancellor. I never spoke with Fr. Burke only with Sister Kathleen Turley)

Sister Kathleen stated to me on the phone that the Bishop would not give a written letter to the Albany Diocese priest recommending they do this project but stated that if the pastors in individual parishes wanted to go ahead with the project then they may do so. If they wanted to call the office to make sure it was permissible to proceed, that would be fine. I called Pauline Cusson to inform her of the good news, but she was still a little uncomfortable that no letter was issued to us. (I never asked for a letter to be sent demanding that the pastors do our project. I only suggested a letter for us to bring to the parishes showing it was o.k. to allow this project to proceed. I have no idea how it got turned into a demand from the Bishop to his pastors. In retrospect, it's no wonder my calls were never returned).

On September 30th I went to Notre Dame to see how much paper was going to be needed. At that time I had Father Gagnon call Sister Kathleen to make sure it was o.k. to go forward with the project. He spoke to her while I was in his office and he told me it was OK! In October 1996, the both Pauline's came to Whitehall to explain how and what we would be doing with his records. Father again told us he saw the books several years earlier in Worcester, MA, really thought we did a great job and that his friend loved them and used them all the time. A letter stating our intent and the due diligence we take in assuring certain records are not included in our work, signed by President Pauline Cusson was presented to Fr. Gagnon for his files.

On October 11th I went to OL Grace and copied that small parish in about 6 hours time. On Nov 8th my mother, Sioban Dussault Bonitatibus and my friend Patti Draiss and I went to Whitehall. With the help of Father's longtime volunteer parishioner, Catherine Lebiere and him, we all copied those old and fragile records dating from 1839 to date – a very precise and tedious but crucial part of the work we do. We completed this phase in about 5 visits. The finished book took almost 1-1/2 years to complete the process of translating the French to English and even Latin to English, data entering thousands of records, printing, proofing, correcting, proofing again and doing the final printing before publishing.

Father Gagnon played a huge role in the success of this project and several others especially since I would have never gotten permission and/or been invited into other parishes if it were not for him! While we were copying ND, Father George told us that Father Joseph Robitaille of St. Joseph in Cohoes, NY wanted to speak to me about doing this work on his old and very tired books as well. I met with him soon after and started his parish on Saturday Nov 30th 1996. Also, Father George had recommended me/us to Father Hogan in Schenectady where Farther George had served several years before. He thought those records needed to be done as well. So St. Columba and Sacred Heart were both copied in two days in Dec of 1996.

I could go on and on about how I got into each of about 30 parishes, but rest assured, it was always by invitation and I always suggested to the Pastors or administrators that they please call the Chancery to be assured that it was permissible to allow us to do this work. Whether or not this step was taken, I have no idea. But I do know that Chuck from St. Joseph in Troy did call to verify what I was telling him. He had me speak to Sister Nola Brunner (Archivist). Again I explained our work to her and again I showed her the finished product, a sample of our books. She granted me permission and also called Chuck at St. Joseph's and gave him the go ahead. When I spoke to her for the 1st time in the spring of 2004, I again asked to have a meeting with the Bishop. She said she would see what she could do. I never heard back on that from her and again last year I asked her for a meeting with him and she never got back to me on that.

I think the bottom line is that for the last 11 years of copying these old books, I've seen much abuse to the unwanted, and in many cases, unused books. Many of the unknowing secretaries tell people they can't even have the basic information from the 1800s or even the early 1900s because in most cases they can't read the Latin, German, Polish, Italian, French, or Lithuanian records. And sometimes just horrible writing from even as late as the recent years precludes the secretaries from being able to read the records, let alone give out any of the information. Some of these precious books are kept in cold wet basements, or very hot rectories where the books are just falling apart at such a rapid rate. Just in the last 10 years where I've had to return to a parish for some incidental copies of records we might have missed in the early sessions, I can no longer see the writing in the records that I once copied. In one case of a recent closed parish, they lost all the registers because a pastor may have thrown them away. (Thank God you do have our work for those records). In a few other incidents, books have been lost [or misplaced]. One pastor who went to a nursing home brought some of his books with him to complete the records. As far as I know, they were never returned to that church (last ten years of records). These stories go on and on like the Titanic song, as the number of pastors watching over the books is declining, so are the books that survive also declining. The new people don't know how or what to do with these books. In many cases now in this Diocese, it is left up to the secretary who never had to deal with the books in the past. The question today now is "OK what do I do with these old records?"

But our interest, and mine, has always been for the good of the church and its people - not to hurt anyone for sure. I've been a practicing Catholic since birth and am a member of St. Anthony Church in Schenectady. My good reputation is known by many pastors - Father Midwig, Father Leo Market, Father Brucker and Father Leo O'Brien as these were my pastors over the years. I'm sure if you contact Father Tony Diacetis he will speak on my behalf. I've not spoken to him in a while but I'm sure he would remember this subject.

Sister had said a complaint came in about an illegitimate that we put in our records. I asked her for the name so we could correct the error as it is the first time such a claim has been made in over ten years of producing these alphabetical indexes. We are so careful in our work - we proofread 3 to 4 times. Our rule is so simple, "if no father is recorded, don't put in." "If the father's last name is not the same as the baby's name don't put it in." No mention of any adoptions in any way, shape or form is allowed to be put in.

Sister Nola has not shown us the name or the erroneous record so we have no way of knowing if it is truly a breach of our policy. We would be devastated if such an error did occur but are most willing to delete it from our files to prevent any re-occurrence of this error in the future. It also puts us back on alert to be more diligent as we proceed in various other Dioceses in Massachusetts and New Hampshire.

With thousands of records copied and only one complaint to your office, I think that is a very good testimonial to our reputation for sure. With our group copying church records for 15 years, we never had a problem. We would like to resolve this problem and to continue our good work.

Thank you for taking the time to try to understand our work. The many thousands of hours that have gone into these projects are 100% volunteer hours. People who care what happens to their family records; volunteers who care about who their ancestors are; volunteers who believe in the preservation of 100 or 150 year old records that are linking them to their heritage of faith, hard work, love of life and Church.

If it is your mandate to stop us from doing this kind of work in your Diocese, so be it. We just find it very confusing when two or three Dioceses of the Catholic Church in our area and all the Dioceses of the Province of Quebec allow this kind of work to proceed up to this day, and then, for no concrete reason, the Diocese of Albany reverses a policy that has been successful for as long as 10 years. With or without a written permission from the Chancery, it should be obvious that we WERE given permission by the individual priests to copy their records in order to produce an alphabetical index to hundreds of years of records, at virtually no cost to the parish; and then to have this alphabetical index at their

fingertips and not have to revert back to and handle 100 year old records, seems to us to warrant further consideration by your office. It was always understood and pointed out at the beginning of each project that these alphabetical indexes would be sold to other genealogical societies in order to recover our costs and make a nominal profit in order to go on to the next church and the next church and the next. Our society is supported primarily by dues income which supports our physical plant in Manchester and sustains our mission to disseminate genealogical information and provide a place for people to do family history. Producing repertoires wherever and whenever we are invited into a parish is also part of our mission to disseminate genealogical information. If we could not sell these indexes to the genealogy community, our expenses would soon overrun our income and we would be forced to halt these worthwhile projects. All proceeds from these repertoires are rolled into the production of more repertoires. We await your response and follow up on the above.
