### **Recording Secretary:**

The charge was set at \$30.00 for early registration made by Sept 21, and \$35.00 for registration at the door.

#### **New Business:**

Gerry reported that there was a good turnout last year. It was agreed that we would participate and we will have to get volunteers and check into getting a tent in case of heat and/or rain.
